### **ORGANIZERS' BACKGROUND**

Corporate governance quality improvement is an imperative task for most of Vietnam enterprises in order to enhance their competitiveness, especially in the increasingly economic integration of the country.

As a response, **Vietnam Association of Corporate Directors (VACD)**, backed by **AsiaInvest Group**, has established **Vietnam Chief Financial Officers Club (Vietnam CFO Club)** in an effort to promote financial and corporate governance. Beside Citibank Vietnam, Mr. Hai also served as CFO of AVON Vietnam and a group of local companies.
